South Asian Federation of Accountants (SAFA), an Apex Body of SAARC was set up in 1984 for promoting the accounting profession in the countries in South Asia and internationally with a mission to bring the accounting bodies in the region together at a common forum and facilitate professional cooperation in the areas of education, training, technical and ethical standards.

SAFA as an Apex Body of SAARC and an Acknowledged Accounting Grouping of IFAC has been playing a pivotal role for the harmonization of professional standards in the areas of accounting, auditing, ethics and education and is committed to raise the level of profession in the Region. SAFA provides special impetus to cooperation amongst its member bodies for the overall growth of the accountancy profession in the SAARC region and explores means in which it, as a representative forum, could play prolific role in the development of the accountancy profession.

The role being played by SAFA for development of the accountancy profession in the SAARC Region and for economic development of the Region as a whole has been exemplified through the innovative work being carried through its various technical Committees working in the area of education, accounting & auditing standards, government accounting, quality control, ethics and many other topical and emerging areas of accountancy profession.

Action Plan for the year 2017

- To work towards harmonization of various facets of accountancy profession in the Region education, accounting, auditing, professional and ethical standards.
- 2. To raise the concerns on issues germane to the accountancy profession so that while drafting international standards, SAFA's concerns are adequately considered. Expedite implementation of the system being developed, whereby comments of any member body, on different Exposure Drafts and Consultation papers issued by IFAC/IASB, are circulated to all member bodies so that views expressed by one member body could be suitably considered by other member bodies of SAFA.
- To organize joint programs with various IFAC Committees, its Independent Boards and IFRS Foundation (IASB) and work closely with IFAC, CAPA, PAFA and other Regional Accountancy Bodies.
- 4. To register SAFA Virtual Knowledge & Training Centre (VKTC) as a special purpose vehicle and to create awareness about SAFA VKTC amongst the general membership and also develop VKTC as a center of excellence for e-learning by general membership of SAFA member bodies.
- 5. To identify such projects and give its value proposition to SAARC which can be undertaken by the SAFA in times to come.
- 6. To create awareness about the SAFA, IFAC and its ongoing activities among the members of SAFA member bodies, regulators nationally in each jurisdiction and alike
- 7. To work towards effective implementation of collaboration signed with International Integrated Reporting Council (IIRC) with an objective to promote Integrated Reporting in SAARC Region.
- 8. To work towards effective implementation of MoUs signed by SAFA with various bodies.

- To hold SAFA Conferences/Seminars regularly and in the countries of SAFA member bodies and to disseminate information about the SAFA Conferences/Seminars amongst the general membership of SAFA member bodies.
- To take projects on topical professional matters for effective delivery by the technical Committees of SAFA.
- 11. To oversee that ICAN is in regular touch with the SAARC Secretariat so that requests for any required support from SAFA may be placed before the SAFA Board for consideration and execution.
- To comply with timely submission of Activity Plan to IFAC, SAARC and other Compliances, if any.
- 13. To work towards achieving IFAC Regional Organization /Strategic Partner status for SAFA so that there is more inter-action between IFAC and SAFA, thus facilitating the implementation of IFAC's requirements across the region of South Asia.
- 14. To work closely with the PAODC Committee of IFAC for the development and strengthening of Accountancy Bodies in SAARC region and get financial support through MOSAIC or other donor bodies for them.
- 15. To assist Afghanistan, Maldives and Bhutan in establishment of Professional Accountancy Bodies and in obtaining financial support through MOSAIC or other donor agencies.
- 16. To undertake reforms for further improvement of the functioning of SAFA.
- 17. To invite representatives of IFAC, donor agencies and other stakeholders as Observers in the meetings of SAFA Board.





The year that was 2017

2017 was a year of resounding attainments and exhilarating developments for the South Asian Federation of Accountants (SAFA). Significant progress has been made on the projects undertaken by various Committees during the year period under report. SAFA has taken various new initiatives out of which some of the important initiatives have been highlighted below:

- Registration of Foundation of SAFA in Sri Lanka to facilitate the operationalisation of Virtual Knowledge and Training Centre of SAFA due to ease of registration in Sri Lanka.
- SAFA Regional CFO Conference 2017 on "Navigating through Digital Transformation towards better Accountability" hosted by the Institute of Chartered Accountants of Bangladesh (ICAB) on January 28, 2017 Pan Pacific Sonargaon Hotel at Dhaka, Bangladesh.
- SAFA International Conference on "SAARC Economic Challenges" hosted by the Institute of Cost and Management Accountants of Pakistan (ICMAP) on April 28 and 29, 2017 at Serena Hotel, Islamabad, Pakistan.
- SAFA International Conference on "Role of Accountants in Economic Development and Sustainability" jointly hosted by the Institute of Chartered Accountants of Nepal and CPA Afghanistan on August 27 and 28, 2017 at Radisson Hotel, Kathmandu, Nepal.
- SAFA International Technical Workshop on Non Compliance with Laws and Regulations (NOCLAR) and IFRS 15 hosted by the Institute of Chartered Accountants of Sri Lanka (ICASL) on October 31, 2017 at Cinnamon Lakeside Hotel, Colombo, Sri Lanka

- Inviting Donor Agencies and other stake holders in the meetings of SAFA Board as Observer.
- SAFA representative, Dr. Suvod Kumar Karn, Vice President, SAFA and Mr. Mudit Vashishtha, Nodal Officer, SAFA had attended the IFAC MOSAIC Forum and PAO Development Committee held in New York, USA.
- SAFArepresentative Mr. Lasantha Wickremasinghe, Board Director attended the IFAC Regional Organization/Accountancy Grouping Meeting and IFAC Council in Brussels, Belgium.

83rd Assembly Meeting

The 83rd meeting of SAFA Assembly was held on January 29, 2017 in Dhaka, Bangladesh. At the meeting, the appointment of new office-bearers for the year 2017 was ratified by the Assembly. Mr. ASM Nayeem, from the Institute of Chartered Accountants of Bangladesh was appointed as the President while CA. (Dr.) Suvod Kumar Karn from the Institute of Chartered Accountants of Nepal was appointed as Vice President for the year 2017. Mr. Mahbub Ahmed Siddique, Director (Technical), ICA, Bangladesh was appointed as the Executive Secretary for the year 2017 and Mr. Binod Neupane, Joint Director, ICA Nepal was appointed as Assistant Executive Secretary.

84th Assembly Meeting

The 84th meeting of SAFA Assembly was held on April 30, 2017 in Islamabad, Pakistan. At the meeting of the Assembly the financial statements of SAFA were approved subject to the required audit. The Assembly also appointed M/s Hingorani M. & Co., Chartered Accountants as the Auditor of SAFA.

85th Assembly Meeting

The 85th meeting of SAFA Assembly was held on November 1, 2017 in Colombo, Sri Lanka, and the meeting was adjourned and continued on December 7, 2017 in Mumbai, India. At the meeting the Assembly confirmed and ratified the resolution on the admission of CPA Afghanistan w.e.f. 1 September 2017, as passed unanimously by email. The Assembly agreed with the recommendation of the Board that CPA Maldives should be removed from the list of SAFA Members since CPA Maldives has become non functional and is not participating in SAFA meetings for the last 4 years. The Assembly also decided that the Auditor General of Maldives should be allowed to continue to attend the SAFA Meetings as Observer.

Board Meetings

To achieve the action plan of SAFA for the year 2017 SAFA has organized five highly productive

Board meetings during the year under report – one each in Bangladesh, India, Pakistan, Nepal and Sri Lanka. Coinciding with the meetings of the Board, meetings of various technical Committees also took place.

- Appointment of Mr. A S M Nayeem, as President, SAFA and CA. (Dr.) Suvod Kumar Karn as Vice-President SAFA for the year 2017.
- Appointment of Mr. Mahbub Ahmed Siddique, Director (Technical), ICA Bangladesh as Executive Secretary and Mr. Binod Neupane, Joint Director, ICAN as Assistant Executive Secretary for the year 2017.
- Decision to establish SAFA Foundation in CA

47th SAFA Board meeting



The 47th SAFA Board meeting was hosted by the Institute of Chartered Accountants of Pakistan on 30th April, 2017 in Islamabad, Pakistan. The following important issues were discussed/noted at the meeting:-

- Articles of Association of Foundation of SAFA was approved with minor modifications for signatures of members.
- Signing of the agreement for CAPEX was deferred till the time OPEX is finalized by the Committee to govern VKTC.
- All the member bodies were requested for remitting the annual membership dues till 2011 within one month time.
- The format for submission of member body reports as prepared by Mr. Muhammad Farhad Hussain for submission of the reports by SAFA member bodies was approved.
- The draft financial statements of SAFA were approved for consideration and adoption by the Assembly subject to the required audit.

48th SAFA Board meeting



The 48th SAFA Board meeting was jointly hosted by the Institute of Chartered Accountants of Nepal and CPA Afghanistan on August 29, 2017 in Kathmandu, Nepal. Ms. Olwyn Connolly, Co chair, World Congress of Accountants Organising Committee attended the meeting and briefed about the developments of WCOA, 2018 in Sydney. Mr. Paul Thompson, European Federation of Accountants and Auditors also attended the meeting and gave an update about the activities of European Federation of Accountants and Auditors.

The following important issues were discussed/ noted at the meeting:-

- Admission of CPA Afghanistan as an Associate member of SAFA recommended to the Assembly for approval.
- 50% of full membership fees may be charged from CPA Afghanistan as Associate membership i.e USD 1100 per annum and the same should be charged proportionately for the year 2017.
- CA Sri Lanka was requested to get the Article 7.1 of proposed Articles of Association of Foundation of SAFA modified so as to ensure that President and Vice President SAFA shall also be on the Board of Foundation of SAFA and to get the revised Articles of Association signed from all the Board members.
- The Board in principle agreed to go ahead with the agreement with the Consultant for development of SAFA Virtual Knowledge and Training Centre and authorized the Committee to Govern VKTC to take appropriate steps in this regard.





- Outstanding membership dues till 2017 were called from all the member bodies to remit by December 31, 2017.
- A Task Force, under the Chairmanship of President, SAFA comprising of Vice President, Permanent Secretary, Prof Lakshman R. Watawala and Mr. Lasantha Wickremasinghe, was constituted for proposing amendments to the Constitution and other organisational reforms in SAFA.

The 49th SAFA Board meeting was hosted by the Institute of Chartered Accountants of Sri Lanka on 1st November, 2017 in Colombo, Sri Lanka. Mr. Arjuna Herath, Chair PAO Development Committee of IFAC addressed at the Board meeting and recognized the significant role being played by SAFA in the development of Accountancy profession in the South Asian Region. Ms Jiwanka Wickremasinghe from World Bank also attended the meeting. The following important issues were discussed/noted at the meeting:-

- Fresh incorporation documents for Foundation of SAFA signed.
- Associates will have the right to attend the Board and Assembly meeting but without any right to vote. The Board also decided that the Associates shall have a right to nominate its representatives on the Committees of SAFA.
- Appointment of Hingorani M. & Co Chartered Accountants as the Auditor of SAFA for the years 2006-2016.

The 50th SAFA Board meeting was hosted by the Institute of Chartered Accountants of India on 7th December, 2017 in Mumbai, India. Ms. Rachel Grimes, President, IFAC addressed the Board members at the meeting. The following important issues were discussed/noted at the meeting:-

- Consultation Paper proposing changes to the international standard setting process for Audit and Ethics and its impact on the International Accountancy profession
- Joint strategic meeting of SAFA and CAPA Board
- Removal of CPA Maldives as Associate member of SAFA with effect from January 1, 2018
- Review of performance of Committees/ Task Force of SAFA
- Awardees of BPA Award were approved

SAFA Best Presented Annual Report Awards & SAARC Anniversary Awards for Corporate Governance Disclosure Ceremony

The SAFA BPA Award for the "Best Presented Annual Reports" is considered as the most prestigious accolade for financial reporting in the South Asian region and signifies SAFA's recognition and reward for organizations in the region which have achieved excellence in presentation and disclosure of high quality, relevant, reliable and objective financial





statements in accordance with the international framework.

SAFA has been organizing Best Presented Annual Report Awards since 1997 in various categories including Banking Sector, Financial Services Sector, Communication & Information Technology Sector, NGO& NPO Sector and alike. In addition SAFA has also initiated SAARC Anniversary Awards for Corporate Governance Disclosures since 2006 and Integrated Reporting Awards since 2015.

The SAFA Committee for Improvement in Transparency, Accountability and Governance (ITAG) had a number of meetings to finalize the winners of SAFA Best Presented Annual Report Awards & SAARC Anniversary Awards for Corporate Governance Competition 2016.
