

Report on Activities of Member Bodies

World Congress of Accountants (WCOA), 2022

The World Congress of Accountants (WCOA) popularly known as the 'Olympics of Accountants' was successfully hosted by the Institute of Chartered Accountants of India in partnership with the International Federation of Accountants (IFAC) from 18 - 21 November, 2022 at Jio World Convention Centre, Mumbai in hybrid mode. The 21st edition of World Congress had the highest ever participation from about 10,000 delegates from over 120 countries i.e. more than 6,500 attended physically while more than 3,300 delegates joined virtually over a specially curated virtual platform.

The World Congress had around 40 sessions spread over the four days covering the most relevant and contemporary topics and were addressed by over 150 eminent international and national thought leaders. The World Congress based on the theme "Building Trust Enabling Sustainability" centred on the continuous engagement and role of the accountancy profession in building trust to support communities and businesses & to build the sustainable, resilient economies that we need for the future. The WCOA also focused upon professional enrichment in contemporary and emerging areas. The WCOA was held for the first time ever in India and was a celebration for India as it steps towards becoming the accounting hub of the world.



On the sidelines of the WCOA 2022, the ICAI hosted and supported various other International meetings and forums commencing from 14th November, 2022.

MoU Signed with Institute of Chartered Accountants of Nigeria and Institute of Chartered Accountants of Nepal (ICAN)

ICAI entered into MoU with the Institute of Chartered Accountants of Nigeria and renewed existing MoU with the Institute of Chartered Accountants of Nepal (ICAN).

Both the MoUs were signed on side-lines of the WCOA2022 and were exchanged in the presence of Shri Devendra Fadnavis, Hon'ble Dy. Chief Minister, Maharashtra. The MoUs will establish mutual co-operation for the advancement of accounting knowledge, professional and intellectual development, advancing the interests of the membership and positively contributing to the development of the accounting profession in Nigeria and Nepal.

Interactive Meeting with Hon'ble Union Minister for Commerce & Industry, Textiles and Consumer Affairs, Food & Public Distribution



Hon'ble Union Minister CA. Piyush Goyal addressed at the WCOA 2022 and spoke about the important role of the profession globally. An Interactive meet of the Minister with the leaders from global professional accounting bodies was organised to discuss about how the global accountancy profession can play a pivotal role in galvanizing economic development as India takes up the presidency of G-20 from 1st December, 2022 with the vision "One Earth, One Family, One Future". The Hon'ble Minister called for collaboration amongst the global accounting fraternity in achieving the agenda of sustainability and building resilient economies of the future. The meeting was attended by more than 70 Global Accounting Professionals.

ICAI National Call Sahayata Beta Version

In order to provide prompt services to the expanding base of members and students, the ICAI is in the process of development of a National Call Sahayata service. A beta version of this was launched on November 21, 2022 in the august presence of Shri Devendra Fadnavis, Dy. Chief Minister, Maharashtra during the WCOA 2022. The National Call Sahayata shall act as one point of contact for the members and students of the Institute.

Mega Career Counselling Programme

The Committee on Career Counselling of the Institute organised a Mega Career Counselling Programme on 31st October, 2022 with the support of its Regional Councils and Branches. Through this programme students from Class IX to Graduation were imparted Career Counselling in order to enable them to take the best suited decision for their future. Approximately 1,30,000 students participated across the Country along with the Principals, Teachers and Career Counsellors. The programme was organised by 81 branches and four Regional Councils simultaneously.

ICAI Campus

134 companies participated in the 56th edition of Campus Placement Programme for the May 2022 Final exam passed students. A total of 5,194 candidates were offered jobs out of which 3,521 candidates accepted the offer. The average salary offered to newly qualified CAs was Rs. 12.48 lakhs. ICAI through its Committee for Members in Industry & Business (CMI&B) and Women Members Empowerment Committee (WMEC) also conducted the first ever placement programme specifically designed for women members only.

Convocation - Welcoming New Talent in the Profession

The ICAI Convocation was held on 6th October, 2022 to award certificates of membership to new members and felicitate rank holders of the CA examinations. The Convocation was organized at 14 different locations across the country and around 16,000 newly enrolled Chartered Accountants received their certificates.

Shri Piyush Goyal, Hon'ble Minister of Commerce & Industry, Consumer Affairs, Food & Public Distribution and Textiles was the Chief Guest at New Delhi. I would like to thank Shri G. Kishan Reddy, Hon'ble Minister of Tourism, Culture and Development of North Eastern Region; Shri (Dr.) Bhagwat Kishanrao Karad, Hon'ble Minister of State for Finance and Shri M R Shah, Hon'ble Judge Supreme Court of India for their gracious presence and words of inspiration for the newly qualified Chartered Accountants at Hyderabad, Aurangabad and Ahmedabad respectively. At other locations also eminent dignitaries graced the Convocation.

Augmenting Competitiveness of MSMEs & Startups

The Institute has always believed in the importance of MSME & Startups to steer the growth of Indian economy. Being one of the focus areas of ICAI, various initiatives have been undertaken for building and improving the capacity and competence of MSMEs and Startups across the country, to ensure realisation of the vision of developing self-reliant economy. ICAI MSME Yatra is one such initiative which was flagged off on 18th August, 2022 from Mumbai to spread awareness about MSMEs & also ensure capacity building. The MSME Yatra, since its launch has covered 52 cities of the states of Maharashtra, Gujarat, Madhya Pradesh, Rajasthan, Punjab, Haryana, Himachal Pradesh, Jammu & Kashmir, Uttarakhand, Uttar Pradesh, Bihar, Assam, West Bengal & Jharkhand up to 17th October, 2022 and will conclude at Mumbai on 18th November, 2022.

A Startup Summit Programme was organised on 8th October, 2022 at New Delhi. The Summit was an initiative to bring together various stakeholders involved in startups to deliberate about promoting entrepreneurship, developments in the Startup ecosystem, funding and valuations, mentoring and experience sharing by the entrepreneurs and experts to build awareness towards strengthening the startup ecosystem. Shri Ramesh Bidhuri, Hon'ble Member of Parliament graced the occasion & around 250 participants physically participated in the said summit.

International Research Awards 2022

ICAI under the aegis of the Research Committee organised an Award Presentation Ceremony for the "ICAI International Research Awards 2022" on 20th October, 2022 in Kanpur. The awards ceremony was graced by Mr. Alan Johnson, President IFAC who addressed the awardees through virtual mode. A total of 13 Research papers were awarded during the ceremony out of 148 entries received from 18 countries.

ICAI Sustainability Reporting Awards 2021-22

With a view to recognising initiatives of businesses with a transformative contribution to the 2030 Agenda for Sustainable Development as well as benchmarking global best practices in Sustainability Reporting, the ICAI through its Sustainability Reporting Standards Board had instituted "ICAI Sustainability Reporting Awards" in the year 2020-21. The 'ICAI International Sustainability Reporting Awards' was started to recognize and award exemplary entities for outstanding contribution to SDGs which have led initiatives towards Gender Equality and Climate Change and have implemented efficient and innovative sustainable practices. Taking the legacy forward, the ICAI has launched "ICAI Sustainability Reporting Awards" and "ICAI International Sustainability Reporting Awards" for the year 2021-22.

Launch of Six ICAI Representative Offices in the United States of America

Enhancing ICAI's global footprints and to position the 'Indian Accountancy Profession' as a 'Brand' worldwide, ICAI launched 6 Representative Offices in the United States of America at Arizona, Austin, Los Angeles, Michigan, North Carolina, and Ohio at an event "Unite in America" organized by our San Francisco Chapter. The grand launch was held on 5th September, 2022 at San Francisco in the august presence of Chief Guest CA. Piyush Goyal, Hon'ble Union Minister, Guest of Honour Mr. Taranjit Singh Sandhu, Hon'ble Ambassador of India to the United States of America, Special Guest Dr. T V Nagendra Prasad, Hon'ble Consul General of India. I and CA. Aniket Sunil Talati, Vice President ICAI attended the event virtually. The Overseas Representative Offices now number 33 in addition to 44 Overseas Chapters.

New Scheme of Education and Training

The Council, after deliberating at length on the suggestions received from stakeholders, approved the Proposed Scheme of Education and Training with certain modifications. The Scheme so approved by the Council has been submitted to the Ministry of Corporate Affairs, along with the corresponding amendments in Regulations for final approval. With active participation of a range of stakeholders and deliberations at meetings of Board of Studies and the Council, we are sure that the resultant outcome, namely, the New Scheme of Education and Training with its value added features, would develop global Chartered Accountants with high level of professional skills and ethical values

Formation of SRO for Social Stock Exchange

The Council of ICAI recently approved the formation of Self-Regulatory Organisation (SRO) for the social auditors as envisaged in the SEBI notification dated 25th July, 2022. The SRO is proposed to be named as "Institute of Social Auditors of India" and will be set up as a Section 8 company under the Companies Act, 2013, under the aegis of ICAI.

ICAI has decided to form the company with the vision to be a leading institution for the development of an independent, ethical, and world-class Social Auditors' profession responding to needs and expectations of the stakeholders. The proposed SRO will focus on capacity building of social auditors through continuous professional advancement with a focus on adherence to the highest ethical standards and compliance with the letter and spirit of social stock exchange requirements.

Standards on Internal Audit (SIAs)- Codifying Best Practices

The Institute of Chartered Accountants of India (ICAI) has always played a pivotal role in the Nation's Standard Setting Framework. In order to keep abreast with the changes in the dynamic business environment, ICAI has been updating the existing Standards & bringing out new Standards on Internal Audit.

These SIAs will go a long way in improving the organizational processes & Audit Quality. This shall also escalate the performance benchmark for Internal Auditors. The Institute has initiated the process of revising Standards on Internal Audit (SIAs) making them principle-based. Revised SIAs are classified and numbered in a series format. Now, six more SIAs providing guidance on important areas are being issued by the Institute. The subjects covered are Risk Management, Internal Auditing in an Information Technology Environment, Third Party Service Provider, Governance, Compliance with Laws and Regulations, and Communication with those Charged with Governance.

Proposed Revision of Empanelment Norms for Government Audit

The O/o C&AG is in the process of revising the empanelment norms of CA Firms and Criteria for Allotment of Audit. The proposed norms as received from the O/o CAG were discussed threadbare and a series of meetings were held at the Institute. Based on the deliberations, ICAI submitted its suggestions to C&AG at a meeting of "Audit Board for Central Public Sector Undertakings" organized by the O/o C&AG on 6th September 2022 wherein the various regulatory counterparts were present. Shri Girish Chandra Murmu addressed the inaugural session.

Various issues related to Revision of Policy for empanelment of Chartered Accountant firms by Office of the C&AG for allotment of audit and need for enhancement of Audit fee/ remuneration of statutory auditors were discussed. It was proposed by the O/o C&AG that additional qualitative parameters should be introduced as part of Allotment Criteria.

MSME Yatra

The ICAI MSME Yatra, an ambitious initiative to support, facilitate and respond to MSMEs was flagged off on 18th August, 2022 from Mumbai. The initiative aspires to promote



the spirit of entrepreneurship amongst MSMEs as well as support MSMEs in improving their productivity through innovation and by way of use of various government schemes. MSME Camp is also organised, wherein the Grievances raised by the MSMEs are resolved in realtime basis and real time Udyam registration of MSMEs also facilitated through ICAI MSME Setu. Since its launch, the MSME Yatra has covered 39 cities.

Under the initiative, awareness is being created towards capacity and competence building of MSMEs for catalyzing the growth of the sector to boost job creation and development of economy. The Yatra has received very positive response from the various State Governments and the events at various places were attended by State ministers, Local Members of Parliament & Members of Legislative Assembly. The ICAI MSME yatra programme at Shimla was graced by Shri Rajendra Vishwanath Arlekar, Hon'ble Governor, Himachal Pradesh as Chief Guest on 21st September,2022.

Formation of ICMAI Social Auditors Organisation

The Institute has constituted a Section 8 company under the Companies Act, 2013 namely, "ICMAI Social Auditors Organisation" for the empanelment, capacity building and regulating the functions of its Members who qualify and get registered as Social Auditors under the SEBI-notified framework for social stock exchanges.

Introduction the Multipurpose Empanelment Scheme (MES)

The Institute has introduced the Multipurpose Empanelment Scheme (MES) for the Practicing Cost Accountants / Cost Accounting Firms with the objective to support various stakeholders in providing rationally evaluated and categorized list of Practicing Professionals (Proprietor / Firm) to them. This system will be of assistance to the Practicing Members and will make available a level playing field to the practitioners whenever information is sought by the stakeholders. This scheme for empanelment of practitioners is effective from 1st January 2023.

National CMA Practitioners Convention (NCPC) 2022

The Institute has organized the National CMA Practitioners Convention (NCPC) 2022 on 7th & 8th October at Pune, Maharashtra, India. The Convention witnessed the active participation of Industrial leaders, eminent speakers and delegates from profession, industry, regulators and government. It was a great opportunity for the budding professionals to understand about the world of the Practicing CMAs as the main emphasis was laid on the Professional Opportunities available for CMAs in Conventional & Non-Conventional Areas.



Adoption of IAASB's Quality Management Standards

The Council of the Institute, on the recommendation of the Auditing Standards & Ethics Committee, has adopted the new and revised Quality Management Standards (ISQM 1, ISQM 2 and ISA 220 (Revised)) issued by the **International Auditing and Assurance Standards Board (IAASB).**

The Council has approved Quality Management Standards as per following effective dates:

Firms	Effective date
Firms performing the audits of public interest companies	Effective from December 15, 2023
Firms performing the audits of other than public interest companies	Effective from December 15, 2024

A firm is required to have the system of quality management (SOQM) designed and implemented in accordance with ISQM 1 by the above effective dates. The evaluation of the SOQM has to be performed within one year following the effective dates. Early adoption of Quality Management Standards are permitted; however, firms are required to adopt all three Quality Management Standards at the same time.


