SAFA Webinar on "Impact of Technology in the Finance Domain" on December 8, 2023



ICMAB Best Corporate Award 2022



Abdur Rahman Khan FCMA, shared that the FE Circular No. 13 dated 24 August 2023 of Bangladesh Bank allows FRC enlisted CMA firms to conduct cash incentive audits through attaining Bangladesh Bank enlistment. He also mentioned other recent achievements that broadened CMAs' practising horizon, e.g., BSEC's circular directing 21 listed companies to comply with the legal requirements for conducting cost audits, valuation of collateral against borrowing from banks and financial institutions, and CMA's inclusion in the Customs Act 2023 as the authorized representative.



Technical Guide on Reports of Audit Under Section 12A/10(23C) of the Income-tax Act, 1961

ICAI has long been committed to advancing the knowledge and honing the skills of its members. In line with this, we are mindful of the recent amendments in the compliance regulations for Charitable Trusts and Institutions under the Incometax Act, 1961, which also witnessed the renotification of Form No. 10B and 10BB. Notably, the updated Form No. 10B and 10BB, released in the final week of August, now demand detailed reporting. Understanding the intricacies of these forms and ensuring the smooth fulfilment of the statutory obligations associated with them has been a priority for ICAI.

To this end, the Direct Taxes Committee (DTC) has released the "Technical Guide on Reports of Audit Under Section 12A/10(23C) of the Incometax Act, 1961". This comprehensive guide provides an invaluable resource for understanding the audit reports required under Sections 12A and 10(23C). Further, in order to resolve the issues being faced by members in filling these audit forms, a series of Live Webinars on Form No. 10B and 10BB were also organised in the month of September and October 2023. These webinars served as a platform for members to gain a practical understanding of the revised forms and the associated reporting requirements.

MoU with IGNOU

a. Adoption of IFRS 17, Insurance Contracts, in Pakistan

SECP, through its S.R.O. 1715 (I)/2023 (dated Nov 21, 2023), has issued notification for applicability of "IFRS 17 Insurance Contracts" on ICAP's recommendation. As per SRO, the companies engaged in insurance/takaful and re-insurance/re-takaful business are directed to follow IFRS 17 from the period commencing from January 01, 2026 for preparation of statement of financial position, profit and loss accounts and other relevant statements and disclosures.

b. Report on IFRS Sustainability Disclosure Standards — Study, consultation and recommendations for implementation in Pakistan

The Accounting Standards Board (ASB) of ICAP, through its Sustainability Working Group, has developed a 'Report on IFRS Sustainability Disclosure Standards – Study, consultation and recommendations for implementation in Pakistan' and shared with members for their comments or suggestions.

The report summarizes the study performed and outcomes of extensive consultations made with companies, auditors, and other stakeholders in recent months on adoption and implementation of the IFRS Sustainability Disclosure Standards in Pakistan. This report, inter-alia, reflects the collective insights and perspectives gathered through various consultative sessions organized in this regard. The outcomes presented in the report will serve as a foundation for informed decision-making for the adoption and implementation of IFRS Sustainability Disclosure Standards in Pakistan.



d. Draft Guidance on Accounting for Minimum Taxes and Final Taxes for comments

ICAP has published a draft guidance on 'Accounting for Minimum Taxes and Final Taxes', for member's feedback through its Circular No. 8/2023 (dated November 16, 2023). The draft guidance is aligned with IAS 12, Income Taxes and covers accounting for the following:

- Final Tax (termed so in the Income Tax Ordinance, 2001)
- Minimum Tax paid under section 113 of the Income Tax Ordinance, 2001



• Minimum Tax paid under other than section 113 of the Income Tax Ordinance, 2001.

The Auditing Standards & Ethics Committee (ASEC) of the Institute has published the 'ISQM Guide and Toolkit' (the Toolkit). The Toolkit aims to provide guidance to audit firms in developing and implementing their System of Quality Management in accordance with ISQM 1 issued by IAASB. The Toolkit contains a Risk and Control Matrix on six components of the ISQM 1, collectively covering a bank of over 120 quality risks and their suggested controls to address those risks.


